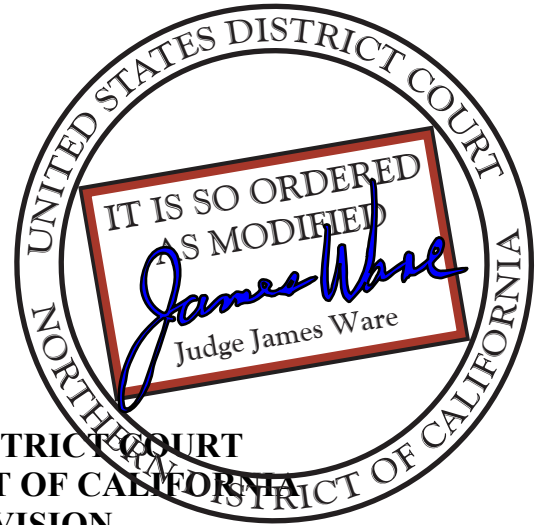

**STIPULATION TO EXTEND THE
 MEDIATION COMPLETION
 DEADLINE; ~~PROPOSED~~ ORDER**

21 WHEREAS, on September 8, 2011, the parties stipulated to submit this dispute
 22 to mediation through the Court’s ADR Program (Docket 18);

23 WHEREAS, on September 20, 2011, the Court entered its order referring this
 24 case to mediation through the Court’s ADR Program (Docket 20);

25 WHEREAS, on November 1, 2011, mediator Mark Penskar was appointed to
 26 mediate this matter (Docket 24);

27 WHEREAS, on November 10, 2011, plaintiff objected to Mr. Penskar’s
 28 appointment and Mr. Penskar’s appointment was thereafter vacated (Docket entry of
 November 10, 2011; Docket 25);

1 WHEREAS, the current mediation completion deadline is December 19, 2011;
2 WHEREAS, on November 15, 2011, the ADR Unit assigned Lynn Fuller as
3 replacement mediator;

4 WHEREAS, given the foregoing and the upcoming holidays, the parties are
5 unsure whether they will be able to meet the December 19 mediation completion
6 deadline;

7 WHEREAS, the parties believe a brief extension is appropriate under the
8 circumstances;

9 IT IS HEREBY STIPULATED that, subject to Court approval, the mediation
10 completion deadline shall be extended to January 31, 2012, or such other time as the
11 Court deems appropriate.


