22 Deputy Hoss; and San Mateo County Sheriff's Deputy Valencia would be tolled for a an
23 additional period of six months, from March 29, 2012 to September 29, 2012;

24 WHEREAS, on February 7, 2012, the Court issued its Order approving said stipulation,
25 and tolled any statute of limitations for a period of six months beyond the date of its order, which
26 is September 29, 2012;


27 IT IS HEREBY STIPULATED BY AND BETWEEN THE PARTIES HERETO THROUGH
