1 Plaintiff COLLEEN MAGUIRE and Defendant CITY OF SANTA ROSA  
2 hereby request that this matter be referred to the ADR mediation program for  
3 settlement discussions.

4 1. The Parties were directed to comply with General Order 56 pursuant to  
5 Scheduling Order filed by Magistrate Judge Laurel Beeler for civil complaints filed  
6 under Title II of the Americans with Disabilities Act (ADA).

7 2. In compliance with General Order 56, the Parties have exchanged Initial  
8 Disclosures, pursuant to FRCP 26, and have conducted a site inspection of the City of  
9 Santa Rosa with their respective experts. Plaintiff has provided Defendant with a  
10 copy of her expert's report identifying barriers and, where appropriate, have also  
11 given recommendations for barrier removal to resolve Plaintiff's claims for injunctive  
12 relief. Defendant has provided Plaintiff with a copy of its expert's report responding  
13 to Plaintiff's expert's report and has furnished date of improvement and title  
14 information.

15 3. The Parties are currently negotiating Plaintiff's proposed barrier removal and  
16 modification of policies and procedures, and are working to reach an agreement  
17 concerning Plaintiff's claims for injunctive relief.

18 4. At this time the Parties would like to be referred to the Court's ADR unit to  
19 mediate their claims with the assistance of a mediator.


