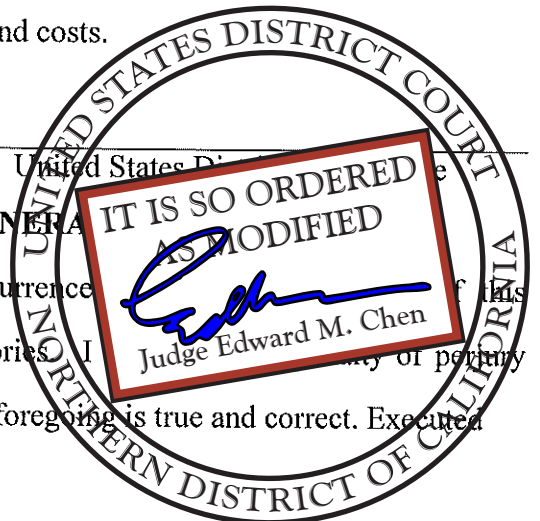
17 In accordance with the foregoing stipulation, IT IS HEREBY ORDERED that plaintiff
