1 Plaintiffs do not assert any claims for monetary relief against Defendant NDeX  
2 WEST, LLC, and Plaintiffs' First Amended Complaint does not allege any misconduct  
3 on Defendant NDeX WEST, LLC's part in the performance of its duties and/or in its  
4 handling of the non-judicial foreclosure as agent for the mortgage lender(s) and/or as  
5 successor trustee under the subject Deed of Trust. Defendant NDeX WEST, LLC shall  
6 have no liability to Plaintiffs for any monetary damages, attorney's fees or costs of  
7

9 suit.

10 Defendant NDeX WEST, LLC shall be bound by any non-monetary judgment or  
11 order that may be entered by the Court concerning (a) ownership and title to the  
12 subject real property, (b) the validity, enforceability and priority of the subject Deed of  
13 Trust, and/or (c) the non-judicial foreclosure proceeding.
