 19 WHEREAS, pursuant to a binding settlement entered on the record on March 22, 2012 before
 20 the Honorable Joseph C. Spero ("Settlement"), Technology & Intellectual Property Strategies Group
 21 PC ("TIPS Group"), Basil P. Fthenakis ("Fthenakis"), Paul L. Hickman and Glenn E. Von Tersch
 22 (collectively "the Parties") have agreed that the current action shall be DISMISSED WITH
 23 PREJUDICE in its entirety with respect to all claims, counterclaims and cross-claims amongst and
 24 between the Parties except: 1) that the Court shall retain jurisdiction over the enforcement of the
 25 rights and obligations set forth in the Settlement; and 2) that TIPS Group and Fthenakis reserve the
 26 right to defend or seek indemnity from each other with respect to any complaint or claim filed by any
 27 current or former client of TIPS Group;

1 IT IS HEREBY STIPULATED by the Parties through their designated counsel that the entire
2 above-captioned action, including all claims, counterclaims and cross-claims amongst and between
3 the Parties, be and hereby is dismissed with prejudice pursuant to F.R.C.P. 41(a)(1); provided,
4 however, that this Court shall retain jurisdiction to enforce the Settlement.

5 The Parties shall bear their own fees and costs.
