19 **STIPULATION; ~~PROPOSED~~ ORDER**

 21 In the wake of the Court’s Order Granting Plaintiff’s *Ex Parte* Motion for Expedited  
 22 Discovery [DKT# 7] (hereinafter “the Order”), Plaintiff Boy Racer, Inc. and a third-party Internet  
 23 Service Provider, Comcast Corporation (hereinafter “Comcast”), made the following negotiated  
 24 stipulation with regards to subscriber response timelines:

25 All subscribers linked directly to Internet Protocol Addresses (hereinafter “IP  
 26 Addresses”) referenced on Exhibit A of the Complaint (DKT#1 at 13) that have been  
 27 issued by the Internet Service Provider Comcast shall be given **30 days** to file any  
 28 motions related to or challenging the subpoenas, including, but not limited to,  
 motions to quash.
