2. Each party shall bear their own costs and attorneys' fees.

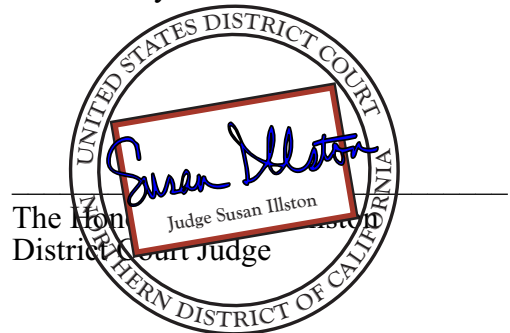
