24 Plaintiff T-Mobile U.S.A., Inc. ("T-Mobile") and Defendants Seiko Epson Corporation,

 26 by and through undersigned counsel, stipulate and agree that T-Mobile hereby dismisses with

1 prejudice all claims being asserted against Epson in the above-captioned action pursuant to
2 Rule 41(a)(2) of the Federal Rules of Civil Procedure. In support of this stipulation of
3 dismissal, the parties state as follows:

4 1. T-Mobile and Epson seek the dismissal with prejudice of all claims asserted against
5 Epson in this action.

6 2. This stipulation does not affect the rights or claims T-Mobile may have against any
7 other defendant or co-conspirator in this litigation.

8 3. Each party shall bear its own costs and attorneys' fees.

9 WHEREFORE, the parties respectfully request that this Court issue the Proposed
10 Order of Dismissal.


[PROPOSED] ORDER
