 20 (“DISH”) (collectively, Olympic and DISH are referred to as the “Parties”) jointly submit this
 21 Stipulation To Extend Time For Filing Of Updated Case Management Statement in this case.

22 WHEREAS, DISH orally moved the Court to stay this action pending re-examination of the
 23 patents-in-suit on November 4, 2011 (the “Stay Motion”) (Docket Number 46);

24 WHEREAS, the Court, in granting the Stay Motion, ordered the Parties to file an updated
