1 The Stipulation of plaintiff Deborah Tamburri and the Defendants Suntrust
2 Mortgage, Inc.; Wells Fargo Bank, N.A.; Mortgage Electronic Registration Systems,
3 Inc.; and U.S. Bank, National Association, having been read and considered, and good
4 cause appearing,

5 IT IS SO ORDERED that:

6 (1) The Stipulation is GRANTED; and

7 (2) Defendant ReconTrust Company, N.A. shall file an Answer to the Plaintiff's
8 Second Amended Complaint, and provide its initial disclosures pursuant to Rule 26(a)
9 by July 30, 2012; and

10 (3) Defendants Suntrust Mortgage, Inc.; Wells Fargo Bank, N.A.; Mortgage
11 Electronic Registration Systems, Inc. and U.S. Bank, National Association shall file
12 their Answers to the Plaintiff's Second Amended Complaint by August 16, 2012;

13 (4) If this case does not settle at the conclusion of mediation, which must be
14 conducted on or prior to August 27, 2012, the Plaintiff and Defendants Suntrust
15 Mortgage, Inc., Wells Fargo Bank, N.A.; Mortgage Electronic Registration Systems,
16 Inc., and U.S. Bank, National Association may engage in discovery pursuant to the
17 Federal Rules of Civil Procedure, and the Court's previous order limiting discovery
18 will no longer remain in effect;

19 (5) Nothing in the Stipulation or this Order should be construed as a waiver of
20 plaintiff filing a third amended complaint (as allowed by the Federal Rules of Civil
21 Procedure), or a waiver of any right by either party.
