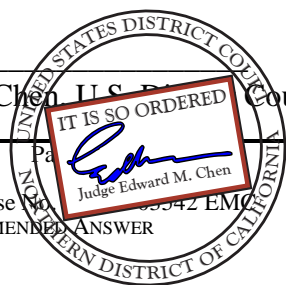
15 Plaintiffs Allen Ansari and Mirjana Ansari currently have a motion to strike pending
