

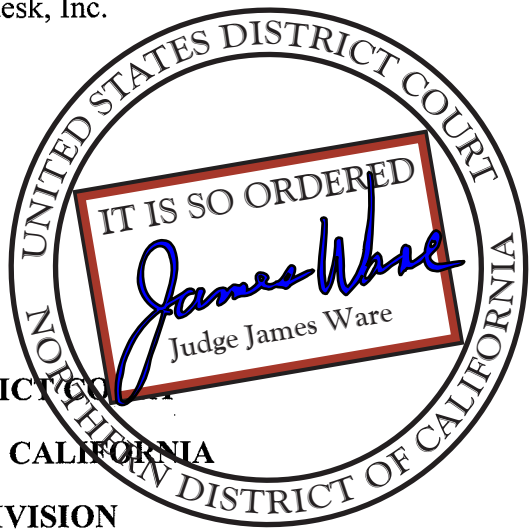

1 **STIPULATION**

2 IT IS HEREBY STIPULATED by and between plaintiff JÖRG PAULE
3 INFORMATIONSSYSTEME, GmbH (“Plaintiff”) on the one hand and defendant AUTODESK,
