1 The Court, having considered the Stipulation Continuing Dates In Connection With
2 Pending Motions For Appointment Of A Lead Plaintiff And Lead Counsel (the "Stipulation"),
3 submitted by plaintiffs Yahia Tawila ("Tawila"), Jane Oh ("Oh"), Iron Workers Mid-South
4 Pension Fund ("Iron Workers"), and Debra Salzman ("Salzman"), as well as by Nominal
5 Defendant Yahoo! Inc. ("Yahoo") and the Individual Defendants, and good cause appearing,
6 HEREBY ORDERS:

7 1. The Court vacates the August 12, 2011 date to file reply briefs in connection with
8 the Re-Noticed Motion and Motion to Consolidate Related Actions, Appoint Lead Plaintiffs and
9 Appoint Co-Lead Counsel (the "Tawila Motion") and the Amended Notice of Motion and
10 Motion to Consolidate Related Actions and Appoint Lead Counsel (the "Iron Workers'
11 Motion"), as previously set by this Court's July 27, 2011 Order Continuing the Hearing Date on
12 Motions to Consolidate Related Actions, Appoint Lead Plaintiffs, and Appoint Lead Counsel;
13 and Extending Briefing Schedules (the "July 27 Order");¹

14 2. The August 26, 2011 hearing on the Tawila Motion and Iron Workers' Motion, as
15 set by the July 27 Order, is vacated.

16 3. The dates set pursuant to Local Rule 7-7(d) for the opposition and reply to the
17 August 5, 2011 Notice of Motion and Motion to be Appointed Lead Plaintiff, and for
18 Appointment of Lead Counsel filed by Salzman (the "Salzman Motion")² are vacated (*i.e.*
19 August 19, 2011 and August 26, 2011, respectively).

20 4. The September 9, 2011 date for a hearing on the Salzman Motion is vacated.

21 5. Only one further brief will be submitted by any party to the above-captioned
22 actions in connection with the Competing Motions, which shall be a reply brief due to be filed on

24 ¹ The deadline to oppose the Tawila Motion and the Iron Workers' Motion is not vacated
25 changed or continued by this Order, however, given that such deadline passed on August 5,
2011.

26 ² As used in this Order, the term "Competing Motions" refers to the Tawila Motion, the Iron
27 Workers' Motion and the Salzman Motion.

1 September 30, 2011 (accordingly, the reply briefs filed by Tawila, Oh, Iron Workers, Yahoo or
2 the Individual Defendants will include their opposition to the Salzman Motion); and

3 6. The hearing for all Competing Motions is set for Friday, October 14, 2011, at
4 10:00 a.m. in the San Francisco Courthouse, Courtroom 6, 17th Floor, 450 Golden Gate Avenue,
5 California, 94102.

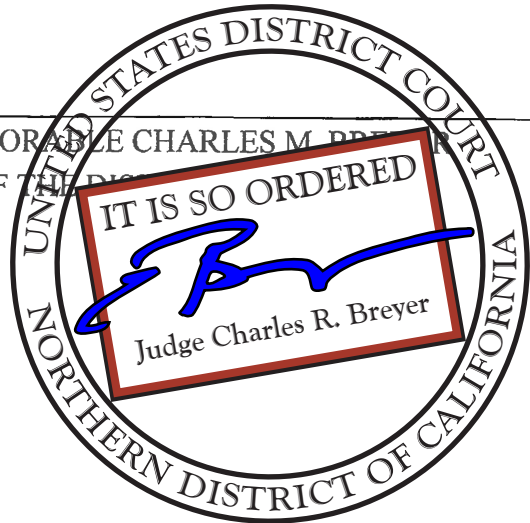
