6 for the Northern District of California.

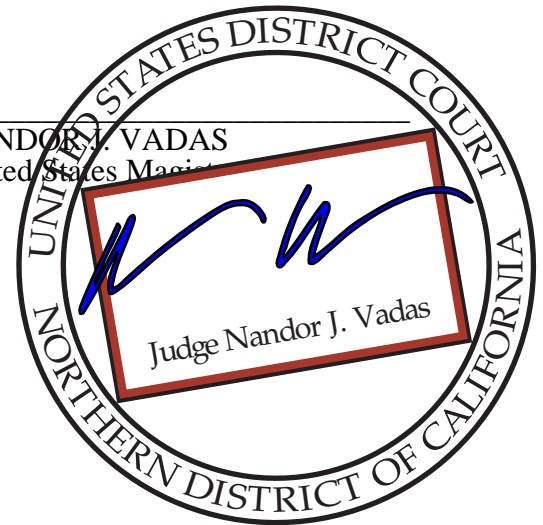
