The *Chandler* matter involves claims by individual plaintiffs who worked as
Home Mortgage Consultants for defendant Wells Fargo, and alleges unpaid
overtime wages pursuant to the Fair Labor Standards Act, 29 U.S.C. § 201 *et seq*.
The plaintiffs in the *Chandler* matter were either involved in the prior MDL action *In Re Wells Fargo Overtime Litigation* as class members prior to the class being
decertified as part of a settlement, or worked for Wells Fargo after the class period in
the prior action.

All Defendants have been served and have answered.

12 To facilitate global resolution, the parties to the *Chandler* action agreed to 13 take a single plaintiff's case to trial as a test case before a magistrate judge without a 14 jury. The parties selected Plaintiff Kelly Dodd as the test plaintiff, and she and 15 Wells Fargo entered into a stipulation and proposed order setting forth their 16 agreement. Judge Chen signed the order (Docket 44), and severed Kelly Dodd's 17 case from the rest of the *Chandler* action (Docket 45). The *Dodd* matter was 18 assigned to Magistrate Judge Maria-Elena James in Courtroom B, and given case 19 number C-13-01365 MEJ. (Docket number 46.) The Dodd matter has been set for 20 trial on April 21, 2014. Discovery in the Dodd matter is underway.


