37 Now before the Court is Plaintiff's Administrative Motion  
 38 for Leave to Serve Summons on ROBERT C. LONGSTRETH via  
 39 publication, and to extend time for service to February 3, 2012.  
 40 The time for filing an opposition to the Motion has expired, and

1 the Court has not received any opposition.

2 After considering the Motion, relevant legal authority, and  
3 the record in this case, the Court hereby GRANTS plaintiff's  
4 administrative motion.

5 IT IS HEREBY ORDERED that service of the Summons in this  
6 action on defendant ROBERT C. LONGSTRETH shall be accomplished by  
7 publication in the *Pacifica Tribune* and the *Mountain Democrat*,  
8 newspapers published in the State of California, and designated  
9 as the newspapers most likely to give actual notice to defendant  
10 ROBERT C. LONGSTRETH.

11 IT IS FURTHER ORDERED that the time to complete service is  
12 extended by 60 days, until February 3, 2012.

13 IT IS FURTHER ORDERED that this Order does not preclude  
14 service upon defendant ROBERT C. LONGSTRETH in any other manner  
15 specified in Fed.R.Civ.P. 4 or in California Code of Civil  
16 Procedure Sections 415.10 through 415.30, which service would  
17 supersede these service by publication.

18 IT IS FURTHER ORDERED that the publication shall be made  
19 once a week for four weeks, and that the deadline by which the  
20 defendant LONGSTRETH shall be served shall be extended to  
21 February 3, 2012.

22 IT IS HEREBY FURTHER ORDERED that if defendant ROBERT C.  
23 LONGSTRETH's address is ascertained prior to the expiration of  
24 the time prescribed for publication of the Summons, a copy of the  
25 Summons and Complaint and of the Order for publication shall  
26 immediately be ~~e~~-mailed to defendant ROBERT C. LONGSTRETH.


