7       5.     PRETRIAL CONFERENCE. The final pretrial conference will be held on **February**  
8 **14, 2013 at 10:00 a.m.**, in Courtroom 3, 17th Floor, United States Courthouse, 450 Golden Gate  
9 Avenue, San Francisco, California. Each party or lead counsel who will try the case shall attend  
10 personally.

11       6.     TRIAL DATE. Trial shall commence on **February 25, 2013 at 9:00 a.m.**, in  
12 Courtroom 3, 17th Floor, United States Courthouse, 450 Golden Gate Avenue, San Francisco,  
13 California.
