12	hearing date of August 9, 2012. Dkt. No. 17. However, Defendant Thomas Perry failed to file an	
13	opposition pursuant to Civil Local Rule 7. Accordingly, the Court ordered Perry to show cause why	
14	the government's motion should not be granted. The Court warned Perry that it would grant the	
15	government's motion without a hearing if he failed to respond. Perry failed to respond.	
16	Accordingly, for the reasons argued in the government's motion and based on Perry's failure to	
17	oppose the motion, the Court hereby GRANTS the government's motion for summary judgment as	
18	follows:	
19	1. On its first cause of action, for \$2,497	7.80 consisting of \$983.68 in principal plus \$1,514.12
20	in interest, as of August 9, 2012, plus \$0.22 per day subsequent to August 9, 2012; and	
21	2. On its second cause of action, for \$4,087.52, consisting of \$1,573.28 in principal plus	
22	\$2,514.24 in interest as of August 9, 2012, plus \$0.15 per day subsequent to August 9, 2012.	
23	THEREFORE, the total judgment in this matter is \$6,585.32 as of August 9, 2012, plus	
24	\$0.37 per day subsequent to August 9, 2012.	
25	IT IS SO ORDERED.
