**STIPULATION AND ~~PROPOSED~~  
ORDER TO STAY PROCEEDINGS  
PENDING RESOLUTION OF CRIMINAL  
PROSECUTIONS**

1 Plaintiffs Barry White, Jr. and Demetrius Anderson, and Defendants City of Antioch,  
2 James Hyde, Allan Cantando, Nicholas Cuevas, Chris Walters, Mike Hulse, Kelly Ouimet,  
3 Leonard Orman, and Mike Mellone, by and through their respective attorneys of record,  
4 hereby stipulate to the following:

5 1. WHEREAS Plaintiffs filed a civil rights complaint in the United States District  
6 Court in the Northern District of California on August 26, 2011, arising out of an incident  
7 relating to the arrests of Plaintiffs by officers of the Antioch Police Department on August 29,  
8 2009;

9 2. WHEREAS the Contra Costa County District Attorney's Office initiated  
10 criminal proceedings against both Plaintiffs on or about May 24, 2010, in connection with the  
11 incident relating to the arrests of Plaintiffs on August 29, 2009;

12 3. WHEREAS Plaintiff Barry White, Jr. is charged with the following felonies  
13 related to that arrest: assault with a deadly weapon upon a peace officer, resisting an executive  
14 officer and a firearm enhancement;

15 4. WHEREAS Plaintiff Demetrius Anderson is charged with the following  
16 misdemeanor related to that arrest: delaying, obstructing or resisting a peace officer;

17 5. WHEREAS Plaintiff Barry White's preliminary hearing in connection with the  
18 criminal charges alleged against him is scheduled to be completed on November 18, 2011;

19 6. WHEREAS Plaintiff Demetrius Anderson's jury trial relating to the criminal  
20 charge alleged against him is scheduled to begin on January 23, 2012;

21 7. WHEREAS Plaintiffs intend to invoke their rights pursuant to the Fifth  
22 Amendment of the United States Constitution in this civil action until the termination of the  
23 criminal prosecutions against them;

24 8. WHEREAS the success of some or all of the claims against the Defendants in  
25 this civil case may turn on the outcome of the criminal prosecutions against Plaintiffs;

26 9. WHEREAS Plaintiffs' claims against Defendants in this civil matter may be  
27 limited and/or barred should either of the Plaintiffs suffer convictions in relation to these

1 pending criminal proceedings;

2 10. WHEREAS there are many overlapping and intertwined issues between the  
3 criminal and civil cases involving the Plaintiffs and going forward on the civil case while the  
4 criminal cases are still pending could lead to inconsistent rulings and/or verdicts.

5 11. WHEREFORE, the parties, by and through their respective counsel,  
6 respectfully seek an Order of the Court to:

- 7 a. stay this case until further Order of the Court,
- 8 b. grant Defendants an extension of time to file a responsive pleading, such  
9 pleading to be filed no later than 20 days after the filing of an order lifting  
10 the stay in this action,
- 11 c. vacate the current Scheduling Order in this case including the December  
12 8th Case Management Conference, and
- 13 d. set this matter for a case management conference during the week of  
14 February 20, 2012, per the availability of the Court.


