) **ORDER OF DISMISSAL**

16 On September 7, 2011, Petitioner, a prisoner of the State of California, filed this  
17 pro se habeas petition. That day, the Clerk notified Plaintiff that he had not filed a  
18 complaint and that he had neither paid the filing fee nor filed a complete application to  
19 proceed in forma pauperis ("IFP"). He was notified that the IFP application was  
20 incomplete because it did not include a certificate of funds form or a prisoner trust  
21 account statement showing transactions for the last six months. Along with the  
22 deficiency notice, the Clerk mailed to Petitioner the Court's complaint and IFP forms,  
23 instructions for completing the forms, and a stamped return envelope. In the notice,  
24 Petitioner was informed that the case would be dismissed if he did not pay the fee or file  
25 a completed IFP application, including the certificate of funds form signed and  
26 completed by a prison official and the proper account statement, within thirty days.  
27 More than thirty days have passed, and no response from Petitioner has been received.

1                   Accordingly, this case is DISMISSED without prejudice, and the pending  
2 incomplete IFP application is DENIED.

3                   The Clerk shall enter judgment and close the file.

4                   IT IS SO ORDERED.
