Good cause exists to continue the mediation deadline in that the parties have engaged in extensive discovery, but further analysis of the parties' claims and defenses is necessary to allow for a productive mediation. Plaintiffs have responded to Defendant's interrogatories, document requests, and requests for admission. Defendants have objected and responded to Plaintiffs' extensive written discovery (91 requests for production of documents by each Plaintiff). Defendants have not yet produced documents responsive to these requests, as they await the entry of a Protective Order filed by joint stipulation on August 2, 2012. (Additional language to the Protective Order was requested by the Court, and the revised Protective Order was submitted on August 29, 2012.) In addition, Defendants have completed the depositions of eight of the twelve Plaintiffs.

In addition to the remaining discovery, which will not be complete before the September 4, 2012 deadline to complete mediation, the parties need additional time to analyze the discovery responses and deposition testimony to develop settlement positions in order for mediation to be successful. The parties have tentatively reserved October 3, 2012 for a mediation before Susan Haldeman, Esq. in San Francisco, this date being subject to the parties' obtaining in advance the discovery necessary to promote a fruitful mediation.
