CASE MANAGEMENT ORDER

15
16 The parties attended a case management conference on January 11, 2012. After
17 considering the representations made by the parties at the conference and the parties' joint case
18 management statement, Dkt. No. 12, the Court orders the following:

19 1. ALTERNATIVE DISPUTE RESOLUTION. This matter is referred to the ADR
20 mediation panel. The parties must complete mediation by March 11, 2012.

21 2. DISCOVERY. The parties must exchange initial disclosures by January 25, 2012.
22 The parties must complete all non-expert discovery by June 29, 2012.

23 3. EXPERT WITNESSES. The disclosure and discovery of expert witness opinions
24 will proceed as follows:

25 (A) By July 16, 2012, plaintiff must disclose expert testimony and reports in accordance
26 with Federal Rule of Civil Procedure 26(a)(2).

27 (B) By August 17, 2012, defendant must disclose expert testimony and reports in
28 accordance with Federal Rule of Civil Procedure 26(a)(2).

1 (C) By September 28, 2012, the parties must complete all discovery of expert witnesses
2 pursuant to Federal Rule of Civil Procedure 26(b)(4).

3 4. FURTHER CASE MANAGEMENT CONFERENCE. A further case management
4 conference will be held on July 11, 2012, at 10:00 a.m. in Courtroom A, 15th Floor, U.S.
5 District Court, 450 Golden Gate Avenue, San Francisco, California. The parties must file a
6 joint case management statement at least one week prior to the conference. *See* Civil L.R. 16-
7 10(d).

8 5. PRETRIAL MOTIONS. The parties must file and serve all pretrial motions no later
9 than October 17, 2012.

10 6. PRETRIAL STATEMENTS. The parties must meet and confer to discuss the
11 preparation of a joint pretrial statement, and on or before November 7, 2012, counsel must file a
12 joint pretrial statement.

13 7. PRETRIAL CONFERENCE. The final pretrial conference will be held on November
14 14, 2012, at 2:00 p.m. in Courtroom A, 15th Floor, U.S. District Court, 450 Golden Gate
15 Avenue, San Francisco, California. Each party or lead counsel must attend the conference.

16 8. TRIAL DATE. Jury trial will begin on December 3, 2012, at 9:00 a.m. in Courtroom
17 A, 15th Floor, U.S. District Court, 450 Golden Gate Avenue, San Francisco, California.

18 IT IS SO ORDERED.
