**STIPULATION TO EXTEND

 20 WHEREAS, Plaintiff Wayne Buder (“Plaintiff”) filed this action, on behalf of
 21 himself and all others similarly situated, against Defendant Quicken Loans, Inc. (“Defendant”) on
 22 September 6, 2011 in the Superior Court of California, County of Marin;

23 WHEREAS, Defendant removed this action to the United States District Court for
 24 the Northern District of California on October 6, 2011;

25 WHEREAS, Defendant filed a Motion to Dismiss Plaintiff’s Complaint or
 26 Alternatively Transfer (“Motion to Dismiss”) on November 3, 2011;

27 WHEREAS, Defendant’s Motion to Dismiss was set for hearing on February 2,

2 WHEREAS, the Initial Case Management Conference is currently scheduled for
3 January 20, 2012 at 1:30 p.m.;

4 WHEREAS, the last day to file Rule26(f) Reports, complete initial disclosures or
5 state objection in Rule 26(f) Report and file Case Management Statement is currently January
6 13, 2012;

7 WHEREAS, pursuant to Civil Local Rules 6-2, 7-7, and 7-12, Plaintiff and
8 Defendant agreed to move the hearing on Defendant's Motion to Dismiss to March 16, 2012;

9 WHEREAS, pursuant to Civil Local Rules 6-2 and 7-12, Plaintiff and Defendant
10 agreed that Plaintiff's Opposition to Defendant's Motion to Dismiss is due on February 10, 2012;

11 WHEREAS, pursuant to Civil Local Rules 6-2 and 7-12, Plaintiff and Defendant
12 agreed that Defendant's Reply is due on March 2, 2012;

13 WHEREAS, pursuant to Civil Local Rules 6-2 and 7-12, Plaintiff and Defendant
14 agreed that the Initial Case Management Conference, if necessary, should be moved to March
15 16, 2012, following the hearing on Defendant's Motion to Dismiss;

16 WHEREAS, pursuant to Civil Local Rules 6-2 and 7-12, Plaintiff and Defendant
17 agreed that the last day to file Rule26(f) Reports, complete initial disclosures or state objection in
18 Rule 26(f) Report and file Case Management Statement should be moved to March 9, 2012;

19 NOW, THEREFORE, Plaintiff and Defendant, through their respective counsel,
20 hereby stipulate as follows:

21 1. Plaintiff Buder shall have until February 10, 2012 within which to file an
22 Opposition to Defendant's Motion to Dismiss in the above-captioned matter;

23 2. Defendant Quicken Loans, Inc. shall have until March 2, 2012 within
24 which to file a Reply to Defendant's Motion to Dismiss in the above-captioned matter;

25 3. The hearing on Defendant's Motion to Dismiss in the above-captioned
26 matter shall be set for March 16, 2012 at 9:30 a.m. in the above-entitled court located at 450
27 Golden Gate Avenue, San Francisco, California, Courtroom G on the 15th floor.

1 4. The Case Management Conference in the above-captioned matter shall be
2 set for March 16 2012, following the hearing on Defendant’s Motion to Dismiss, in the above-
3 entitled court located at 450 Golden Gate Avenue, San Francisco, California, Courtroom G on
4 the 15th floor.

5 5. The last day to file Rule26(f) Reports, complete initial disclosures or state
6 objection in Rule 26(f) Report and file Case Management Statement shall be March 9, 2012.
