1 BY AND THROUGH THEIR COUNSEL OF RECORD, THE PARTIES STIPULATE AS
2 FOLLOWS:

- 3 1. On October 11, 2013, the Court issued the Order Staying Action. (Dkt. No. 92)
4 2. Pursuant to the Court's instructions in the Order Staying Action, the stay lifted on October 18,
5 2013, the date of restoration of funding to the Department of Justice. Therefore, the parties

12 5, 2013.


