
ADMINISTRATIVE CLOSURE

1 On February 8, 2013, Plaintiffs filed a settlement agreement and stipulation for entry of
2 judgment (Docket Number 73). The stipulation calls for the entry of judgment only if Defendant
3 E & L Young Enterprises, Inc. defaults in making installment payments. Therefore, Plaintiffs
4 requested that this case be administratively closed. As there appears to be no reason at this time to
5 maintain the file as an open case, the Court finds an administrative closure appropriate and
6 instructs the Clerk of the Court to close this case for statistical purposes. Nothing contained in this
7 Order shall be considered a dismissal or disposition of this action and, should further proceedings
8 in this litigation become necessary, any party may initiate it in the same manner as if this Order
9 had not been entered.

10 **IT IS SO ORDERED** that this case be Administratively closed.

11 **IT IS FURTHER ORDERED** that the dates in the December 18, 2012 Order Setting
12 Pretrial Deadlines are cancelled and the Case Management Conference scheduled for March 29,
