**STIPULATION & [PROPOSED ORDER] TO CONTINUE ORAL ARGUMENT AND STAY THIS
COURT'S RULING ON PLAINTIFF'S MOTION TO REMAND UNTIL JUNE 15, 2012**

Case No. 3:11-cv-05132-CRB

1 This Stipulation and [proposed] Order is entered into by Plaintiffs YASMIN MARTINEZ
2 (“Plaintiff”) and Defendant WIRELESS LIFESTYLE, INC. (“Defendant”) (hereinafter the
3 “Parties”) as follows:

4 WHEREAS, on September 19, 2011, Plaintiffs filed the instant proposed wage and hour
5 class action against Defendant;

6 WHEREAS, on October 19, 2011, Defendant removed the instant action on the grounds that
7 this Court had original federal jurisdiction under 28 U.S.C. § 1332;

8 WHEREAS, Plaintiffs filed a *Motion to Remand* on November 1, 2011, and a decision on
9 that Motion is currently pending;

10 WHEREAS oral argument on *Plaintiffs’ Motion to Remand* was stayed pending the
11 resolution of Wireless Lifestyle’s motion to transfer to a multi-district litigation (“MDL”)for
12 centralized pretrial proceedings;

13 WHEREAS oral argument on *Plaintiffs’ Motion to Remand* has not yet been re-scheduled;

14 WHEREAS the Parties have agreed to engage in a global mediation that, in addition to the
15 Parties to the instant Action, also includes the plaintiffs in the following three putative wage and
16 hour actions pending against Defendant in various judicial districts in California and Missouri:
17 *Frazier v. Wireless Lifestyle, Inc.*, 3:11-cv-05192-MMC; *Coleman v. Wireless Lifestyle Inc.*, 5:11-
18 cv-01727-RGK-AJW; *White v. Pasha Distribution Corp.*, 4:11-cv-00975-ODS;

19 WHEREAS the Parties have agreed to use their best efforts to complete mediation no later
20 than May 24, 2012;

21 WHEREAS the Parties shall promptly notify this Court after the conclusion of the
22 mediation whether a settlement was reached;

23 WHEREAS the instant Stipulation is contingent upon the occurrence of the mediation set
24 forth herein, the Parties reserve the right to request that the Court reset a hearing on *Plaintiffs’*
25 *Motion to Remand* for a date earlier than June 15, 2012 in the event that the anticipated mediation
26 does not occur;

27 IT IS HEREBY STIPULATED that the Court enter an order continuing oral argument and
28 staying a ruling on Plaintiffs’ Motion to Remand until June 15, 2012.

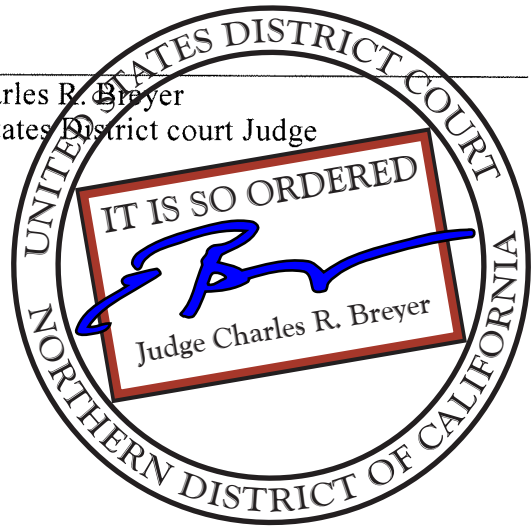
