1 Before the Court is the Joint Stipulation to Modify the Hearing Date on Defendant
2 Wireless Lifestyle's Motion to Stay Proceedings Pending Resolution of Motion to Transfer to
3 MDL between Plaintiffs KEVIN FRAZIER AND DEJESUS LIBRAN, on behalf of themselves
