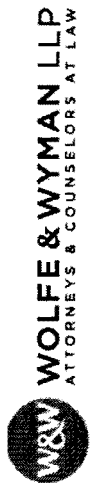

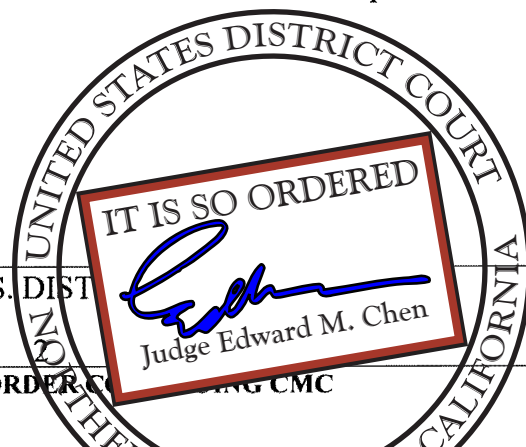
19 The Court, having reviewed the Stipulation Continuing Case Management Conference, and



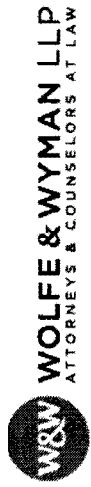
