15 **IT IS HEREBY ORDERED** that, pursuant to Rule 16(b), Federal Rules of  
16 **Civil Procedure, and Civil L.R. 16-10, a Case Management Conference will be**  
17 **held in this case before the Honorable Susan Illston on** \_\_\_\_\_

18 **at 2:30 p.m. in Courtroom No. 10, 19th floor Federal Building.**

19 **Plaintiff(s) shall serve copies of this Order at once on all parties to this**  
20 **action, and on any parties subsequently joined, in accordance with the**  
21 **provisions of Fed.R.Civ.P. 4 and 5. Following service, plaintiff(s) shall file**  
22 **certificate of service with the Clerk of this Court.**

23 **Counsel are directed to confer in advance of the Case Management**  
24 **Conference. Not less than seven days before the conference, counsel shall**  
25 **file a joint case management statement in compliance with the Civil Local**  
26 **Rules and the Standing Order for All Judges of the Northern District of**  
27 **California. Failure to file a joint statement shall be accompanied by a signed**  
28 **declaration setting forth the grounds for such failure. Failure to show good**  
**cause for such failure may subject the parties to sanctions.**

Each party shall be represented at the Case Management Conference by counsel prepared to address all of the matters referred to in this Order, and with authority to enter stipulations and make admissions pursuant to this Order. The parties are encouraged to attend.

Any request to reschedule the above dates should be made in writing, and by stipulation, if possible, not less than ten days before the conference date. Good cause must be shown.

At the case management conference the parties should be prepared to address and resolve the following: setting the date and the estimated length of the trial; setting the date for discovery cutoff; setting the date to designate experts and other witnesses; and setting the date for the pretrial conference.

Standing Orders: All parties shall comply with the Standing Order for All Judges of the Northern District of California concerning the contents of the joint case management conference statement and Judge Illston's Standing Order.

Failure to comply with this Order or the Local Rules of this Court may result in sanctions. See Fed.R.Civ.P. 16(f), Civil L.R. 1-4.

**NOTICE TO PRO SE LITIGANTS IN NON-PRISONER ACTIONS:**

If you are proceeding in this lawsuit without an attorney, and have not been granted leave to proceed *in forma pauperis*, then the following directives apply to you in the prosecution of your case.

The court hereby ORDERS you to comply with the service requirements of Rule 4 of the Federal Rules of Civil Procedure as set forth below. Failure to follow the procedures set forth in this order may result,

under Rule 4 (m), in dismissal of your case.

It is your responsibility to obtain a valid summons from the clerk and to effect service of the summons and complaint on all defendants in accordance with

Rule 4 of the Federal Rules of Civil Procedure. If you have named the United States government, a federal agency, a federal official or a federal employee as a defendant, you must comply with the special requirements of Rule 4 (i).

Service may be effected by any person who is not a party and who is at least 18 years of age, which means that you, as a party, may not effect service. If service of the summons and complaint is not made upon a defendant within 120 days after the filing of the complaint, your action will, under Rule 4 (m), be dismissed as to that defendant.

Within 125 days after the filing of the complaint, you must file proof of service indicating which defendants were served within the 120 days allowed under Rule 4 (m) and showing, in accordance with Rule 4 (i), how each of those defendants was served (for example, by attaching appropriate certificates of service). You must also show cause why a defendant not served within the 120 days allowed under Rule 4 (m) should not be dismissed without prejudice.

Failure to do these things within the designated time will result in the dismissal of your case under Rule 4 (m) and Rule 41 (b).

5 **1. Scheduling Days:**

8 **Civil Law and Motion Calendar is conducted on Fridays at 9:00 a.m.**

10 **Criminal Law and Motion Calendar is conducted on Fridays at 11:00 a.m.**

13 **Civil Case Management Conferences are generally conducted on Fridays at**  
14 **2:30 p.m. with the order of call determined by the Court.**  
15

16 **Pretrial Conferences are generally conducted on Tuesday afternoons at 3:30**  
17 **p.m.**

20 **Counsel need not reserve motion hearing dates, but may call the clerk to**  
21 **obtain the next available law and motion calendar. Motions may be reset as**  
22 **the Court's calendar requires. All parties are directed to comply with the**  
23 **Civil Local Rules except as identified in this Order.**

25 **2. Discovery Disputes:**  
26

27  
28 **The parties shall meet and confer in person, or, if counsel are located outside**  
**the Bay Area, by telephone, to attempt to resolve their dispute informally. A**  
**mere exchange of letters, e-mails, telephone calls, or facsimile transmissions**

does not satisfy the requirement to meet and confer.

1           **If, after a good faith effort, the parties have not resolved their dispute, they**  
2           **shall prepare a concise joint statement of 5 pages or less, stating the nature and**  
3           **status of their dispute. Absent an order of this Court, parties shall not file**  
4           **affidavits or exhibits, other than copies of the written requests for discovery and**  
5           **the answers or objections thereto.**

6  
7  
8           **If a joint statement is not possible, each side may submit a brief individual**  
9           **statement of 2 pages or less. The joint statement or individual statements shall**  
10          **be filed or e-filed, if in an e-filing case, and courtesy copies submitted as**  
11          **provided by the Civil Local Rules.**

12  
13           **The Court will advise the parties regarding the need, if any, for more formal**  
14          **briefing or a hearing, pursuant to Civil Local Rule 7-1(b).**

15  
16           **3. Sealed Documents (Civil L.R. 79-5; G.O. 62):**

17  
18           **This Court does not require the filing of Administrative Motions to seal (Civil**  
19          **L.R. 7-11). The Court will accept stipulations (Civ. L.R. 7-12) or an ex-parte**  
20          **application (Civ. L.R. 7-10) with proposed orders in lieu of the administrative**  
21          **motion. In the event an agreement and stipulation for leave to file under seal**  
22          **is not possible, an ex-parte application shall be filed instead. Oppositions to**  
23          **ex-parte applications and proposed order must be submitted to the Court**  
24          **immediately.**

6 **STANDING ORDER FOR ALL JUDGES OF THE NORTHERN DISTRICT**  
7 **OF CALIFORNIA**

8  
9 **CONTENTS OF JOINT CASE MANAGEMENT STATEMENT**

10 **Commencing March 1, 2007, all judges of the Northern District of California**  
11 **will require the identical information in Joint Case Management Statements**  
12 **filed pursuant to Civil Local Rule 16-9. The parties must include the following**  
13 **information in their statement which, except in unusually complex cases, should**  
14 **not exceed ten pages:**

- 16 **1. Jurisdiction and Service: The basis for the court's subject matter**  
17 **jurisdiction over plaintiff's claims and defendant's counterclaims, whether any**  
18 **issues exist regarding personal jurisdiction or venue, whether any parties**  
19 **remain to be served, and, if any parties remain to be served, a proposed**  
20 **deadline for service.**
  - 21 **2. Facts: A brief chronology of the facts and a statement of the principal**  
22 **factual issues in dispute.**
  - 23
  - 24 **3. Legal Issues: A brief statement, without extended legal argument, of the disputed points**  
25 **of law, including reference to specific statutes and decisions.**
  - 26 **4. Motions: All prior and pending motions, their current status, and any anticipated**  
27 **motions.**
  - 28
  - 5. Amendment of Pleadings: The extent to which parties, claims, or defenses are expected**  
**to be added or dismissed and a proposed deadline for amending the pleadings.**

1           **6.     Evidence Preservation: Steps taken to preserve evidence relevant to the issues**  
2           **reasonably evident in this action, including interdiction of any document-destruction program**  
3           **and any ongoing erasures of e-mails, voice mails, and other electronically-recorded material.**

4           **7.     Disclosures: Whether there has been full and timely compliance with the initial**  
5           **disclosure requirements of Fed. R. Civ. P. 26 and a description of the disclosures made.**

6           **8.     Discovery: Discovery taken to date, if any, the scope of anticipated discovery, any**  
7           **proposed limitations or modifications of the discovery rules, and a proposed discovery**  
8           **plan pursuant to Fed. R. Civ. P. 26(f).**

9           **9.     Class Actions: If a class action, a proposal for how and when the class will be certified.**

10          **10.    Related Cases: Any related cases or proceedings pending before another judge of this**  
11          **court, or before another court or administrative body.**

12          **11.    Relief: All relief sought through complaint or counterclaim, including the amount of**  
13          **any damages sought and a description of the bases on which damages are calculated. In**  
14          **addition, any party from whom damages are sought must describe the bases on which it**  
15          **contends damages should be calculated if liability is established.**

16          **12.    Settlement and ADR: Prospects for settlement, ADR efforts to date, and a specific ADR**  
17          **plan for the case, including compliance with ADR L.R. 3-5 and a description of key discovery**  
18          **or motions necessary to position the parties to negotiate a resolution.**

19          **13.    Consent to Magistrate Judge For All Purposes: Whether all parties will consent to have**  
20          **a magistrate judge conduct all further proceedings including trial and entry of judgment.**

21          **14.    Other References: Whether the case is suitable for reference to binding arbitration, a**  
22          **special master, or the Judicial Panel on Multidistrict Litigation.**

23          **15.    Narrowing of Issues: Issues that can be narrowed by agreement or by motion,**  
24          **suggestions to expedite the presentation of evidence at trial (e.g., through summaries or**  
25          **stipulated facts), and any request to bifurcate issues, claims, or defenses.**

26          **16.    Expedited Schedule: Whether this is the type of case that can be handled on an**  
27

expedited basis with streamlined procedures.

1       **17.     Scheduling:** Proposed dates for designation of experts, discovery cutoff, hearing  
2 of dispositive motions, pretrial conference and trial.

3       **18.     Trial: Whether the case** will be tried to a jury or to the court and the expected length of  
4 the trial.

5       **19.     Disclosure of Non-party Interested Entities or Persons:** Whether each party has filed the  
6 “Certification of Interested Entities or Persons” required by Civil Local Rule 3-16. In addition,  
7 each party must restate in the case management statement the contents of its certification by  
8 identifying any persons, firms, partnerships, corporations (including parent corporations) or  
9 other entities known by the party to have either: (i) a financial interest in the subject matter in  
10 controversy or in a party to the proceeding; or (ii) any other kind of interest that could be  
11 substantially affected by the outcome of the proceeding.

13       **20.     Such other matters** as may facilitate the just, speedy and inexpensive disposition of this  
14 matter.
