14 After considering the Joint Case Management Statement submitted by the parties and  
15 consulting with the attorneys of record for the parties and good cause appearing, IT IS HEREBY  
16 ORDERED THAT:

17 1. DISCOVERY. On or before February 15, 2013 all non-expert discovery shall be  
18 completed by the parties.

19 2. EXPERT WITNESSES. The disclosure and discovery of expert witnesses and  
20 opinions shall proceed as follows:

21 A. On or before March 22, 2013, parties will make initial expert disclosures in  
22 accordance with Federal Rule of Civil Procedure 26(a)(2).

23 B. On or before April 12, 2013, parties will designate their supplemental and rebuttal  
24 experts in accordance with Federal Rule of Civil Procedure 26(a)(2).

25 C. On or before May 3, 2013, all discovery of expert witnesses pursuant to Federal  
26 Rule of Civil Procedure 26(b)(4) shall be completed.

1           3.       FURTHER CASE MANAGEMENT CONFERENCE. A Further Case

7 Courtroom 3, 17th Floor, United States Courthouse, 450 Golden Gate Avenue, San Francisco,  
8 California.

9           5.       PRETRIAL CONFERENCE. The final pretrial conference will be held on  
10 **November 7, 2013 at 10:00 a.m.**, in Courtroom 3, 17th Floor, United States Courthouse, 450  
11 Golden Gate Avenue, San Francisco, California. Each party or lead counsel who will try the  
12 case shall attend personally.

13           6.       TRIAL DATE. Trial shall commence on **November 18, 2013 at 9:00 a.m.**, in  
14 Courtroom 3, 17th Floor, United States Courthouse, 450 Golden Gate Avenue, San Francisco,  
15 California.
