14 Pursuant to Rule 16(b) of the Federal Rules of Civil Procedure, the parties attended a
15 Case Management Conference on November 1, 2012. After considering the Joint Case
16 Management Statement submitted by the parties and consulting with the attorneys of record for
17 the parties and good cause appearing, IT IS HEREBY ORDERED THAT:

18 1. DISCOVERY. On or before February 15, 2013 all non-expert discovery shall be
19 completed by the parties.

20 2. EXPERT WITNESSES. The disclosure and discovery of expert witnesses and
21 opinions shall proceed as follows:

22 A. On or before March 22, 2013, parties will make initial expert disclosures in
23 accordance with Federal Rule of Civil Procedure 26(a)(2).

24 B. On or before April 12, 2013, parties will designate their supplemental and rebuttal
25 experts in accordance with Federal Rule of Civil Procedure 26(a)(2).

26 C. On or before May 3, 2013, all discovery of expert witnesses pursuant to Federal
27 Rule of Civil Procedure 26(b)(4) shall be completed.

1 3. PRETRIAL MOTIONS. All pretrial motions must be filed and served pursuant to
2 Civil Local Rule 7. All pretrial motions shall be heard on August 1, 2013.

4 **January 16, 2014 at 10:00 a.m.**, in Courtroom 3, 17th Floor, United States Courthouse, 450
5 Golden Gate Avenue, San Francisco, California. Each party or lead counsel who will try the
6 case shall attend personally.

7 7. TRIAL DATE. Trial shall commence on **January 27, 2014 at 9:00 a.m.**, in
8 Courtroom 3, 17th Floor, United States Courthouse, 450 Golden Gate Avenue, San Francisco,
9 California.
