REASONS FOR THE REQUESTED ENLARGEMENT OF TIME

On March 12, 2012, Defendants Hillard Sterling and Freeborn & Peters filed a Motion to Dismiss and Motion to Strike Complaint. The Responses are due on March 26, 2012. The Replies are due on April 9, 2012, 14 days after the filing of the Responses instead of 7 days required by the CIVIL L.R. 7-3(c).
