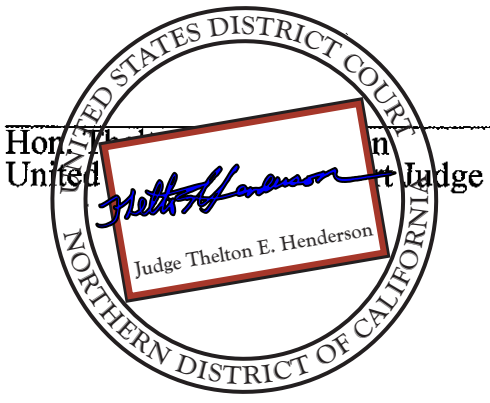


- 1. The Motion is GRANTED.
