1 Plaintiff James Gross and Defendants Symantec Corporation and PC Tools, Ltd.
2 (collectively, the “Parties”), by and through their undersigned counsel, hereby stipulate and agree,
3 subject to Court approval, to vacate the case management conference and hearing on Symantec’s
4 pending motion to dismiss currently set for February 22, 2013 at 10:00 a.m. In support of the
5 instant stipulation, the Parties state as follows:

6 **WHEREAS**, the Parties have reached a settlement of this putative class action;

7 **WHEREAS**, a case management conference and a hearing on Symantec’s motion to
8 dismiss the Second Amended Complaint are currently set for February 22, 2013;

9 **WHEREAS**, the Parties will be finalizing all settlement documents and Plaintiff will be
10 filing a motion for preliminary approval of the class action settlement on or before Thursday,
11 February 28, 2013;

12 **NOW THEREFORE, IT IS HEREBY STIPULATED AND AGREED** as follows:

16 and Plaintiff shall file his motion for preliminary approval of the settlement.
