21 Counsel for Petitioner has continued to review the file and the case and to prepare the traverse, but he
22 needs additional time to do so. This is brought about, in part, by counsel's work in connection with the
23 state prisoners's hunger strike at San Quentin State Prison and California State Prison – Corcoran, and
24 by other matters.

25 Counsel for Respondent has graciously agreed to an additional extension of sixty (60) days –
26 subject to the Court's approval – to allow counsel for Petitioner time to undertake the necessary work.
