20 Petitioner Tyler Redick's traverse currently is due April 18, 2014. Counsel has completed his  
21 investigation and he is preparing the traverse for filing. However, he will not be able to finalize the  
22 traverse by the current due date due, in part, to other time-sensitive matters. With the anticipated work  
23 remaining, and in light of the other time-sensitive matters, counsel expects to be able the traverse with a  
24 further extension of forty-five (45 days), and he requests this, rather than another extension of thirty (30)  
25 days.
