24 IT IS HEREBY STIPULATED by the parties hereto, through their respective undersigned
 25 attorneys of record, as follows:

26 The Court issued its Order Granting in Part and Denying in Part Defendants Motion for Summary
 27 Judgment on October 24, 2013 [Docket No. 85]. The Court informed the parties after the MSJ oral
 28 argument on October 16, 2013 that depending on the Court's final decision on the MSJ if the matter was

1 going to proceed to trial that the parties should meet and confer on a new trial date for a date sometime in
2 March or April, 2014 because the Court was no longer available for jury trial on February 24, 2014.

3 There is a further Case Management Conference now scheduled for Tuesday November 12, 2013.
4 The parties have been unable to meet and confer on a new trial date, expert discovery and related matters
5 based on the Court's Order denying in and granting in part the MSJ since plaintiffs' counsel has been in
6 New York the week of October 25, 2013 and defense counsel is out of the country the week of
7 November 2, 2013 returning Monday November 11, 2013.

8 To provide the parties more time to complete the meet and confer process and consult with their
9 clients, witnesses and experts about a new trial date, discovery and experts the parties respectfully
10 request and stipulate for an Order moving the Case Management Conference now scheduled for Tuesday
11 November 13, 2013 to Tuesday December 3, 2013 at 200 pm for trial setting. A Joint Case Management
12 Conference Statement to be filed November 26, 2013.
