1 The Parties to the above-captioned matters have reached a global settlement in both
2 cases, including the pending motion for attorneys' fees filed by Respondent Stationary Engineers
3 Local 39 Health and Welfare Trust Fund ("Trust Fund") and have entered into a fully executed
4 Settlement and General Release Agreement. Pursuant to the Settlement and General Release
