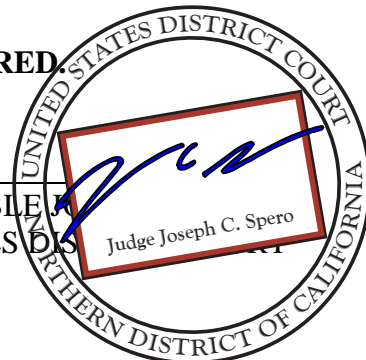
18 Based on the above stipulation, and for good cause appearing, IT IS ORDERED as follows:
