1	deemed complete April 28, 2012. Plaintiffs are currently seeking relief through Defendant's
2	insurer, and may amend the complaint to name the insurance company as a defendant. Therefore,
3	although Defendant is in default, Plaintiffs have not yet requested an entry of Default.
4	Plaintiffs will either amend the complaint to name the insurance company, or will seek an
5	entry of default against Defendant, and then move for default judgment. Accordingly, Plaintiffs
6	respectfully request that the Court continue the Case Management Conference set for June 14,
7	2012 for ninety (90) days, to allow time for amendment or for a Motion for Default Judgment to be
8	heard.
