18 This stipulation is entered into by Plaintiffs Alex Soto and Vince Eagen (“Plaintiffs”) and  
19 Defendant American Honda Motor Co., Inc. (“Honda” or “Defendant”) (collectively, the  
20 “Parties”), by and through their respective counsel, with reference to the following facts and  
21 recitals:

22 A. Plaintiffs filed their Class Action Complaint in the subject action on  
23 March 19, 2012.

24 B. The Court previously ordered the following briefing schedule regarding Plaintiffs’  
25 forthcoming Motion for Class Certification:

- 26 • Plaintiffs’ Motion for Class Certification April 8, 2013

- 1 • Defendant's Opposition June 10, 2013<sup>1</sup>
- 2 • Plaintiff's Reply July 15, 2013

4 C. On March 25, 2013, pursuant to the Court's March 19, 2013 Order (Docket Entry  
5 # 64), counsel for the Parties met and conferred by telephone regarding the completion of  
6 Defendant's review and production of ESI in response to Plaintiffs' document requests, the  
7 scheduling of a deposition of Defendant pursuant to FED. R. CIV. P. 30(b)(6), and extension of  
8 the schedule concerning briefing on Plaintiffs' motion for class certification.

9 D. Subject to the Court's approval, the Parties herby stipulate to the following  
10 schedule by which Defendant will make up to (4) productions of ESI responsive to Plaintiffs'  
11 Second Set of Requests for Production of Documents Propounded to Defendant (Aug. 30, 2012),  
12 as amended and supplemented by Plaintiffs' counsel's letter to Defendant's counsel (Oct. 24,  
13 2012), thereby completing production by April 30, 2013:

- 14 • Defendant's Production #13 April 12, 2013
- 15 • Defendant's Production #14 April 19, 2013
- 16 • Defendant's Production #15 April 26, 2013
- 17 • Defendant's Production #16 April 30, 2013

18 E. Subject to the Court's approval, the Parties also stipulate to a forty-six (46) day  
19 extension of the briefing schedule regarding Plaintiffs' forthcoming Motion for Class  
20 Certification in order to permit Defendant to complete its production of ESI and to permit  
21 Plaintiffs to complete the deposition(s) of Defendant pursuant to FED. R. CIV. P. 30(b)(6):

- 22 • Plaintiffs' Motion for Class Certification May 24, 2013
- 23 • Defendant's Opposition July 26, 2013
- 24 • Plaintiff's Reply August 30, 2013
