

1	stipulation, based on the recitals below:
2	1. On April 2, 2012, Plaintiff filed a Class Action and Representative Action Complaint
3	for Damages, Equitable and Injunctive Relief ("Complaint");
4	2. The parties filed a Stipulation re Extension of Time to Respond to Complaint,
5	extending the deadline to June 11, 2012;
6	3. On June 11, 2012, ConAgra filed its Motion to Dismiss the Complaint, noticing the
7	motion for hearing on August 10, 2012, the same day as the initial Case Management
8	Conference is calendared
9	4. In order to permit themselves more time to brief the issues raised by ConAgra's
10	Motion to Dismiss and to accommodate counsel's calendars, the parties have agreed,
11	subject to Court approval, to a briefing schedule in connection with the Motion to
12	Dismiss whereby the deadline for each party's filing is altered from the deadline that
13	would otherwise be required by the Local Rules;
14	5. The proposed briefing schedule is sought in good faith and not for purposes of delay;
15	IT IS HEREBY STIPULATED, by and between the parties through their respective
16	counsel, that:
17	1. Plaintiffs' Opposition papers to Defendant's Motion to Dismiss shall be filed no
18	later than July 6, 2012; and
19	2. Defendant's Reply papers shall be filed no later than July 20, 2012.
