2 1. Plaintiff Jessica Orozco filed the above civil rights action which alleges that she  
3 suffered gunshot wounds on September 17, 2011 as an innocent bystander to a police action  
4 being undertaken by officers from the San Francisco Police Department;

5 2. Plaintiff Jose Garcia filed the above civil rights action in which he alleges he  
6 suffered gunshot wounds as an innocent bystander during the same police action;

7 3. Both actions have been referred to Magistrate Judge Donna M. Ryu for settlement  
8 conference;

9 4. Both actions involve the same facts and applicable law and differ only in the nature  
10 and extent of their respective claims for damages;


11 5. Plaintiff Garcia's case is scheduled for settlement conference before Magistrate
