**CASE MANAGEMENT
SCHEDULING ORDER**

Pursuant to Rule 16(b) of the Federal Rules of Civil Procedure, the parties attended a Case Management Conference on August 30, 2012. After considering the Joint Case Management Statement submitted by the parties and consulting with the attorneys of record for the parties and good cause appearing, IT IS HEREBY ORDERED THAT:

1. ALTERNATIVE DISPUTE RESOLUTION.

MEDIATION. This matter is referred to mediation to be completed within 120 days of the issuance of this order. The parties shall promptly notify the Court whether the case is resolved at the mediation.

2. DISCOVERY. On or before February 28, 2013, all non-expert discovery shall be completed by the parties. Discovery shall be limited as follows: (a) ten (10) non-expert depositions per party; (b) thirty-five (35) interrogatories per party, including all discrete subparts; (c) a reasonable number of requests for production of documents or for inspection per party; and (d) a reasonable number of requests for admission per party.

3. EXPERT WITNESSES. The disclosure and discovery of expert witness opinions shall proceed as follows:

1 A. On or before April 12, 2013, plaintiff shall disclose expert testimony reports in
2 accordance with Federal Rule of Civil Procedure 26(a)(2).

3 B. On or before April 26, 2013, defendant shall disclose expert testimony and reports in
4 accordance with Federal Rule of Civil Procedure 26(a)(2).

5 C. On or before June 28, 2013, all discovery of expert witnesses pursuant to Federal Rule of
6 Civil Procedure 26(b)(4) shall be completed.

7 4. FURTHER CASE MANAGEMENT CONFERENCE. A Further Case Management
8 Conference shall be held on **March 14, 2013 at 10:00 a.m.** in Courtroom 3, 17th Floor, United
9 States Courthouse, 450 Golden Gate Avenue, San Francisco, California. The parties shall file a
10 Joint Case Management Statement at least one week prior to the Conference.

11 5. PRETRIAL MOTIONS. All pretrial motions must be filed and served pursuant to
12 Civil Local Rule 7. All pretrial motions shall be heard no later than September 12, 2013.

13 6. PRETRIAL STATEMENTS. At a time convenient to both, counsel shall meet and
14 confer to discuss preparation of a joint pretrial statement, and on or before December 5, 2013,
15 counsel shall file a Joint Pretrial Statement.

16 7. PRETRIAL CONFERENCE. The final pretrial conference will be held on
17 **December 19, 2013 at 10:00 a.m.**, in Courtroom 3, 17th Floor, United States Courthouse, 450
18 Golden Gate Avenue, San Francisco, California. Each party or lead counsel who will try the case
19 shall attend personally.

20 8. TRIAL DATE. Trial shall commence on **January 13, 2014 at 9:00 a.m.**, in
21 Courtroom 3, 17th Floor, United States Courthouse, 450 Golden Gate Avenue, San Francisco,
22 California.
