22 Pursuant to Civil Local Rules 5 and 6-1, the parties, through their respective counsel of
 23 record, hereby stipulate as follows:

24 1. Plaintiff Patrick Missud ("Missud") filed a Complaint against Oakland Coliseum
 25 Joint Venture, City of Oakland, Alameda County, SMG Corporation and Does 1 – 100 on June 7,
 26 2012.

27 2. To avoid arguments regarding potential service issues, Missud and defendants
 28 Oakland Coliseum Joint Venture and SMG Corporation stipulate and agree that defendants Oakland
