On August 20, 2012, Defendants filed a motion to dismiss. Pursuant to Northern District Civil Local Rule 7-3(a), Plaintiffs' opposition was due by no later than September 6, 2012. Plaintiffs have not filed an opposition brief. Accordingly, Plaintiffs are HEREBY ORDERED TO SHOW CAUSE, in writing, by no later than October 1, 2012, why this case should not be dismissed for failure to prosecute. If Plaintiffs seek leave to file a belated opposition brief to Defendants' motion, then by October 1, 2012, they must file and serve a request showing good cause for a belated filing accompanied by a proposed opposition brief. If the Court grants Plaintiffs leave to file an opposition brief, it shall set a deadline by which Defendants may reply. The hearing scheduled for October 5, 2012 is VACATED pending further order of the Court.


If Plaintiffs fail to comply with this Order by October 1, 2012, the Court shall dismiss this case for failure to prosecute without further notice to Plaintiffs.

The Court AGAIN ADVISES Plaintiffs that the Handbook for Pro Se Litigants, which

contains helpful information about proceeding without an attorney, is available through the Court's website or in the Clerk's office. The Court also advises Plaintiffs that they also may wish to seek assistance from the Legal Help Center. Plaintiffs may call the Legal Help Center at 415-782-9000, extension 8657, or sign up on the 15th Floor of the Courthouse, Room 2796, for a free appointment with an attorney who may be able to provide basic legal help, but not legal representation.
