ORDER ON MOTION TO SEAL

On October 11, 2013, Defendant Google Inc. moved pursuant to Civil Local Rule 79-5(d) and California Civil Code section 3426.5 to seal portions of the parties' Discovery Dispute Joint Report #2 ("Joint Report") and Exhibit B thereto.

Because this is an action alleging trade secret misappropriation, and because the Joint Report and the exhibit contain or describe Plaintiff's alleged trade secrets, the Court finds good cause for the motion to seal. Accordingly, Google's motion to seal is GRANTED.
