- I am the Chief Executive Officer of Plaintiff Be In Inc. and am responsible for all aspects of the business, including developing business strategies.
- 3. Be In's interrogatory responses are quoted in the parties' Discovery Dispute Joint Report #2. Excerpts of Be In's July 1, 2013 responses and October 1, 2003 supplemental responses to Google's first set of interrogatories are attached to Joint Report #2 as Exhibit B.
- 4. The quotes and excerpts from Be In's interrogatory responses in Joint Report #2 describe Be In's strategies for Google to use CamUp or a CamUp-like platform to advance Google's business. These strategies were provided to Google pursuant to a non-disclosure agreement, which required Google to maintain their confidentiality and not to disclose them to third parties.
