18 THE PARTIES HEREBY STIPULATE AND AGREE AS FOLLOWS:

19 1. On September 27, 2012, Plaintiffs filed their First Amended Complaint (Doc. 18) in
 20 this case alleging violations of the Fair Debt Collection Practices Act, 15 U.S.C. § 1692 *et seq.*, and the
 21 Rosenthal Fair Debt Collection Practices Act, Cal. Civil Code § 1788 *et seq.*

22 2. On February 27, 2013, Defendants filed their Answer to First Amended Complaint
 23 (Doc. 46).

24 3. Thereafter, on August 26, 2013, the Court entered a Civil Pretrial Order for Jury
 25 Trial (Doc. 64) in this case which set October 31, 2013, as the discovery cutoff, and January 15, 2014,
 26 as the last date on which dispositive motions would be heard.

1 4. The parties have completed their discovery in this case and, in light of the
2 forthcoming Holiday Season, propose the following briefing schedule for the Court's consideration and
3 approval:

- 4 a. All dispositive motions shall be filed by November 20, 2013;
- 5 b. All oppositions shall be filed by December 11, 2013;
- 6 c. All replies shall be filed by December 18, 2013;
- 7 d. All dispositive motions shall be heard on January 15, 2014, at 2:00 p.m. in
8 Courtroom 2, 17th Floor.

9 5. The parties have not previously submitted a proposed briefing schedule in this case.

10 6. The proposed briefing schedule will have no effect on the January 15, 2014, hearing
11 date previously set by the Court.


